E Canyon Road Guardrail

2016 LHSIP Group Guardrail Project, Sponsor: East Side Highway District No. 3 Key # 18721

Description: This safety improvement project will make improvements on Canyon Road from the Rose Lake Exit (Exit 34) on Interstate 90 to the Kootenai County Line (6.9 miles). The Highway District is applying for funds to place additional guardrail and replace existing guardrail where it will become too low to be effective after the overlay. The guardrail will be installed in areas with crash history, on curves, and where warranted and feasible along Canyon Road.

Status: Funding for Project Development will be obligated in FY2015. The State and Local Agreement for Grouped Guardrail Project has been prepared and sent to East Side Highway District No.3 for signature.

Ramsey Road UPRR Upgrade, Sponsor: Lakes Highway District Key # 18755

Description: This safety improvement project will install gates, flashing lights and sound signals to improve safety at this railroad crossing location near the City of Hayden. The ADT at this crossing is currently 1,100 vpd and is expected to increase to 6,500 vpd in the year 2035. The existing configuration is limited to signs and pavement markings, which are referred to as standalone passive controls. Standalone passive controls provide no information to motorists to whether a train is approaching such as what would be provided with flashing lights.

Status: Funding for Project Development will be obligated in FY2015. The State and Local Agreement is prepared and is being sent to the Lakes Highway District for signature.

Durable Pavement Marking and Delineators

2016 LHSIP Group Sign Project, Sponsor: Bonner County Key # 18765

Description: This project will install delineators and paint (MMA) edgeline markings as safety enhancements on nine (9) Bonner County maintained roadways. Nine roadways have been selected due to their number and severity of accidents, traffic volume, and large number of curves: 1) E Dufort Road; 2) Cocolalla Loop; 3) Kelso Lake Road; 4) Peninsula Road; 5) East River Road; 6) East Shore Road; 7) Rapid Lightning Road; 8) East Side Road and 9) Samuels Road

Status: Funding for Project Development will be obligated in FY2016. The State and Local Agreement is being prepared and will be sent to Bonner County for signature.

Slaughter House Bridge, Sponsor: Benewah County Key # 18813

Description: The Slough Bridge on St. Joe City Road is a one lane bridge in very poor condition. The bridge has been on the watch list for Benewah County for many years. The guardrails are substandard and because of the narrow width, the rails are damaged from many logging truck impacts.

Status: This project is in the ITIP and currently scheduled under Preliminary Development. It is waiting for design funding.

Cow Creek Road Guardrail

2016 LHSIP Group Guardrail Project, Sponsor: Boundary County Key # 18825

Description: This project would install guardrail to address the overturns on outside curves but could also help with the head-ons that occurred within a few hundred feet of the Cow Creek/Crossport intersection. Driven steel posts are the best option due to road width and a hard substrate. This project represents guarding the critical outside curves only.

Status: Funding for Project Development will be obligated in FY2015. The State and Local Agreement for Grouped Guardrail Project has been prepared and sent to Boundary County for signature.

Once replaced, there will be two way access up this first one half mile of winding road all the way to Administration Lane, where the majority of traffic leaves Ruby Creek Road.
