Ramsey Road Union Pacific Railroad Crossing Upgrade, Sponsor: Lakes HD Key # 18755

Description: This safety improvement project consists of installing gates, flashing lights and sound signals to improve safety at this railroad crossing location near the City of Hayden. The ADT at this crossing is currently 1,100 vehicles per day (vpd) and is expected to increase to 6,500 vpd in the year 2035. The existing configuration is limited to signs and pavement markings, which are referred to as standalone passive controlism, providing no information to motorists to whether a train is approaching compared to flashing lights.

Status: We are awaiting an executed Railroad Agreement. Once agreement is signed obligation of funds can occur.

Slaughter House Bridge, Sponsor: Benewah County Key # 18813

Description: The Slough Bridge on St. Joe City Road is a narrow bridge in very poor condition that needs replacing. The bridge has been on the watch list for Benewah County for many years. The guardrails are substandard and because of the narrow width, the rails are damaged from many logging truck impacts. This project is going to replace the existing structure.

Description: This project includes installing chevrons, delineators and durable pavement marking on thirteen roadways with high severity crashes, high volumes and a large number of curves.

Pine Creek Rd Bridge over Pine Creek, Sponsor: Shoshone County Key # 19718

Description: This project includes replacing the existing Pine Creek Road Bridge located over Pine Creek in Shoshone County. The bridge's substructure is in critical condition, and the most recent inspection report shows an overall sufficiency rating of 16.5. The steel piles are rusted, the bridge abutments are cracking and the concrete on the southwest wing wall has spalled, exposing rebar. Significant scour has occurred and the bridge railing has also been damaged.

Status: This project is in the ITIP and currently scheduled under Preliminary Development. We are awaiting design funding.

Riverview Drive Guardrail Installation, Sponsor: Post Falls HD Key # 19749

Description: This is a high volume roadway with a large number of curves and large number of severe crashes. This project includes installing guardrail at three locations along Riverview Drive: roughly 650 feet of guardrail and roughly 320 feet of retaining wall.

Status: The consultant selection process has been initiated.

Schweitzer Cutoff Bridge, Sponsor: City of Sandpoint Key # 9171LB

Description: Due to funding constraints, the project has been separated into two phases. The majority of the work will include constructing a new structure over Sand Creek. In addition, Phase 2 begins where Phase 1 has left off which extends the reconstruction and widening of roadway that includes bicycle, pedestrian and drainage facilities of Schweitzer Basin Cutoff Road from milepost 100.236 to milepost 100.354. Also during Phase 2 the roundabout will be built funded 100% by Sponsor at the intersection of Schweitzer Basin Cutoff Road/Boyer Ave.

Additionally, existing guardrail is deficient and does not meet current standards.

Schweitzer Basin Cutoff Road, Sponsor: City of Sandpoint Key # 9171

Description: Due to funding constraints, the project has been separated into two stages. Stage 1 includes reconstructing and widening Schweitzer Basin Cutoff Road from milepost 100 to milepost 100.194 (construction continues to milepost 100.236) to accommodate new bicycle, pedestrian and drainage facilities.

Status: This project was substantially complete in November 2016. A few punch list items will need to be completed in the spring of 2017. CE&I consultant is beginning closeout of the project.
