## Managing Floodplain Development through the National Flood Insurance Program (NFIP)

### Date:

August 13-16, 2018

### Location:

Idaho Falls, ID

### Course Description:

Hosted by FEMA Region X and the Idaho Department of Water Resources (DWR). This course is designed for local officials responsible for administering their local floodplain management ordinance. The course will focus on the National Flood Insurance Program (NFIP) and concepts of floodplain management, maps and studies, ordinances administration, and the relationship between floodplain management and flood insurance.

### Certified Floodplain Manager Exam:

Registration for the Certified Floodplain Manager (CFM) Exam on August 17, 2018 is a separate process completed through Association of State Floodplain Managers (ASFPM). Additional information can be found at <https://www.floods.org/index.asp?menuid=405&firstlevelmenuid=180&siteid=1>.

### Target Audience:

Local officials responsible for administering local floodplain management ordinances, including floodplain management administration, building inspectors, code enforcement/zoning officers, planners, city/county managers, attorneys, engineers, and public work officials. Federal/state/regional floodplain managers are also encouraged to attend. The course is designed for those officials with less than three years of floodplain management experience.

### Funding:

Tuition is free for those accepted; there are no travel/salary stipends available for this offering and all incurred costs are the responsibility of the attendee or sending organization.

### To Apply:

**FEMA Form 119-25-1 Application:**

**Applicants will need to put their Student Identification (SID) in place of their social security number.** If you do not yet have a SID, just follow these three simple steps to obtain one:

**Step 1:** To register, go to: <https://cdp.dhs.gov/femasid/>.

**Step 2:** Click on the “Register for a FEMA SID” button in the middle of the screen.

**Step 3:** Follow the instructions and provide the necessary information to create your account.

Enrollment confirmations will be sent approximately 30-days prior to the course via email.
