Description: This project replaces the existing S 2nd West Street bridge over Egin Canal. The proposed structure will be a 62-foot single-span precast concrete voided slab bridge, founded on piles socketed into bedrock. Construction will require maintaining flow to the downstream power plant and relocating utilities.

Status: This project is awaiting FY19 funding obligation. The project's PS&E package will likely be submitted to ITD by

March 2019.

E 1300 N, Ora Bridge, Sponsor: Fremont County Key # 12122

Description: This project is to replace the existing bridge located 2.5 miles west of the City of Ashton and less than 1 mile downstream of the Ashton Dam in Fremont County. The new bridge will be 484 foot 4 span prestressed concrete girder bridge over the Henry's Fork of the Snake River. Nearly 1200 feet of approach work will be required for the new bridge. The existing bridge will be removed.

Status: The project will be starting in March and is anticipated to be complete in October, 2020.

Pence Bridge Wetland Monitoring, Sponsor: Lost River HD Key # 20839

Description: This project is the continued monitoring and maintenance of the three wetland mitigation sites for the Pence Bridge Project.

Status: The first year of monitoring will begin summer or fall of 2019, following construction, when the vegetation has established enough to determine establishment. The area will be monitored by Butte Soil and Water Conservation District. Each year they will prepare a monitoring report to be submitted by the Local Highway Technical Assistance Council to the United States Army Corps of Engineers for review. Any necessary maintenance identified will be completed by the Lost River Highway District.

5000 South Wetland Monitoring, Sponsor: Madison County Key # 20840

Description: This project is the monitoring of a wetland mitigation site for the Archer Lyman Highway project. Two years of monitoring were completed under the Archer Lyman construction project. The remaining eight years will be monitored under this project.

Status: The most recent monitoring report indicated a significant presence of Canadian Thistles. Madison County has been notified of the invasive species (weed) and recommended removal methods were provided to the county in the last (second) monitoring report. The next site monitoring will occur late summer or early fall of 2019. The success of the removal of the Canadian Thistle will be evaluated in the monitoring report. Monitoring and the associated reports are prepared by a consultant (Horrocks) and are submitted by the Local Highway Technical Assistance Council to the United States Army Corps of Engineers.
