### **Ramsey Rd; Wyoming Ave To Lancaster Rd, Sponsor: City of Hayden Key # 12310**

**Description:** This project will provide a new connection of Ramsey Road from Wyoming Avenue to Lancaster Road.

**Status:** The Final Design Review has been completed for this project. The Plans, Specifications, and Estimate are scheduled for review submittal in April of 2021. Right-of-Way appraisals will begin in the summer of 2021.

**Description:** This project includes replacing the existing Pine Creek Road Bridge located over Pine Creek in Shoshone County. The bridge's substructure is in critical condition; the most recent inspection report shows an overall sufficiency rating of 16.5. The steel piles are rusted, the bridge abutments are cracking and the concrete on the southwest wing wall has spalled, exposing rebar. Significant scour has occurred and the bridge railing has also been damaged.

**Description:** The West Fork Pine Creek Road Bridge over Pine Creek project is located near the City of Pinehurst in Shoshone County and includes rehab of the existing single-span concrete bridge.

Rapid Lightning Creek Bridge has the second lowest sufficiency rating of any bridge in Bonner County. The bridge's substructure is in poor condition and load restriction shows an overall sufficiency rating of 38.8. Additionally, existing guardrail is deficient and does not meet current standards.

**Status:** A final concept report and the bridge Type, Size, and Location report have been submitted for approval. Environmental work is underway.

The bridge railings also have significant spalling with exposed rebar, and guardrail ends treatments do not meet modern safety standards.
