# District 1 Projects in Design Phase Quarterly Update January through March 2025

### Pine Creek Rd Bridge over Pine Creek, Sponsor: Shoshone County, Key Number: 19718

**Description:** This project includes replacing the existing Pine Creek Road Bridge located over Pine Creek in Shoshone County. The bridge's substructure is in critical condition; the most recent inspection report shows an overall sufficiency rating of 16.5. The steel piles are rusted, the bridge abutments are cracking and the concrete on the southwest wing wall has spalled, exposing rebar. Significant scour has occurred and the bridge railing has also been damaged.

**Status:** The consultant submitted the project Plan, Specifications, and Estimate (PS&E) package to LHTAC in February, 2025. The project will be advertised for construction in Fiscal Year 2026.

### Chase Rd BNSF RRX, Sponsor: City of Post Falls, Key Number: 19955

**Description:** This project is to reconstruct the approaches to the crossing at Chase Road and the BNSF branch line serving Post Falls. The project is located on SMA-7515 at mile point 1.414.

Status: The project consultant is currently working on final BNSF railroad permits so the Plan, Specifications,

and Estimate (PS&E) submittal can be finalized and construction funds can be obligated.

This includes a replacement and relocation of a structurally deficient bridge across the UPRR and realigns Old Highway 95 to provide an improved connection to a future interchange at Parks Road and US 95.

**Status:** The consultant is currently developing Preliminary Design Plans and working on the Environmental Document.

Final Design in order to complete the Environmental Document.

### Ramsey Rd; Wyoming Ave To Lancaster Rd, Sponsor: City of Hayden, Key Number: 12310

**Description:** This project includes replacing the existing Main Street Bridge located over Pine Creek between Silver Street and Seventh Street. The bridge's substructure is in critical condition; the most recent bridge inspection report shows a sufficiency rating of seven.

**Status:** The construction contract has been awarded and the contractor anticipates work will begin in July of 2025.

### Rapid Lightning Cr Br, Bonner Co, Sponsor: Bonner County, Key Number: 20207

**Description:** This project includes replacing the existing Rapid Lightning Creek Bridge located over Rapid Lightning Creek in Bonner County. Rapid Lightning Creek Bridge has the second lowest sufficiency rating of any bridge in Bonner County. The bridge's substructure is in poor condition and load restriction shows an overall sufficiency rating of 38.8. Additionally, existing guardrail is deficient and does not meet current standards.

**Status:** The project is currently in construction and approximately 50% complete. The anticipated completion is in the fall of 2025.
